1 (one) Research Fellowship for R&D Initiation (BII) for BSc Student

1 Research Fellowship(s) for R&D Initiation (BII) is(are) open at the FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências, for the project/R&D institution "Exploring the evolutionary origin of sentience", "2022.05256.PTDC", funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme R&D Projects In All Scientific Domains, Exploratory Research Projects (PeX) - 2022, under the following conditions:

- 1. Scientific Area: Biology, Law, or Philosophy.
- 2. **Requirements for admission**: Knowledge of the English language (in particular proficiency in reading and writing) is necessary.
- 3. Additional optional skills and qualifications: Student of 3rd year of Bachelor's degree in biology, law or philosophy. Demonstrable expertise in bioethics will be considered a preferential skill during the selection process. A particular interest on themes related to sentience research and its legislative aspects, such as animal welfare and protection, will be considered a futher preferential skill during the selection process.
- 4. **Contracting requirements**: Presentation of the academic qualifications and/or diplomas. Enrolment in Bachelor's Degree in Biology, Law or Philosophy.
- 5. **Work plan**: One of the outputs of the project EVORISE (https://evorise.rd.ciencias.ulisboa.pt) is to articulate a prospective bioethical paper on the foundations of sentientist ethics. Sentientism is the ethical theory according to which moral status or consideration depend on sentience ascription. The widening of sentience ascription to a large(r) part of the biota potentially creates a challenge for sentientist ethics: unless sentientism finds a way to satisfactorily answer the related questions of how to conceptualise and characterise with precision the degree of sentience sufficient for moral considerability, it might be argued that a new kind of foundation for organismal moral considerability is needed. The Fellowship holder will become a full member of the project's team. The main task of the Fellowship holder will be to critically assess relevant legislative frameworks and directives for animal protection and welfare (e.g., Portugal, New Zealand, UK, EU). The researcher will redact a report with a comparative analysis of their respective rationales (e.g., relative to the sentience indicators supporting the spirit of the legislation). The report will inform the development of the project's outcome. The team's plan is to articulate an article in a prominent science policy or bioethical journal on the ethical foundations of sentientism. The aim of the article is to serve for local and EU science policy.

- 7. **Place of work**: The work will be developed at the Centro de Filosofia das Ciências da Universidade de Lisboa (CFCUL), Campo Grande, Lisboa, Portugal under the scientific supervision of Professor Davide Vecchi.
- 8. **Fellowship duration**: This position is initially opened for 6 months due to start in September 2023.

- 9. **Monthly allowance**: The fellowship amounts to € 541,12, according to <u>table values</u> of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.
- 10. **Evaluation and selection process**: Candidates will be assessed by The selection process has two phases. In the first phase, two criteria will be used:
- a) Relevant expertise clearly stemming from the analysis of the CV (maximum 3 pages) 60%;
- b) Motivation letter, with a sound and clear justification of the candidate's interest in the project (with a length of maximum 500 words) 40%.

After the preliminary evaluation, the best 3 (three) candidates will be contacted for an interview. And the final evaluation will be obtained considering the sum of the criteria a) and b) (70%) and the interview (30%). Applicants whose application is scored with a final classification of less than 60 points are not eligible for granting a fellowship.

- 12. **Publication/notification of results**: All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
- 13. **Deadlines**: This call for applications is open from 22/05/2023 to 19/06/2023.
- 14. **Application:** Applications should be sent via e-mail to dvecchi@fc.ul.pt, by attaching the following documents:
 - a. Curriculum vitae;
 - b. Certificate of completion of previous degree;
 - c. Motivation letter (maximum 500 words in length).
- 15. **Processing of personal data:** FCiências.ID Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

The personal data will be kept for the period necessary for the execution of the purposes for which they are intended, being ensured the processing and protection in an appropriate and diligent way, the confidentiality and integrity of these data, through appropriate technical and organizational measures.

Personal data may be transmitted to third parties, namely the entity funding the research project, solely for the purposes specifically established. In this sense, whenever the transfer of personal data to countries outside the European Union and/or international organizations is necessary, compliance with the applicable legal provisions is ensured.

16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCiências.ID (fciencias-id@fciencias-id.pt) within 15 business days after the notification date

Note 1: The documents that prove the entitlement of the academic qualifications and diplomas, or the proof of registration in the academic degree or diploma requested on the call, can be dismissed during the application period and replaced by a declaration on their honour from the applicant. Their delivery is mandatory for the fellowship contractualization.

Note 2: Please note that - higher education degrees and diplomas awarded by foreign higher education institutions need to be recognized by a Portuguese higher education institution, pursuant to the Decree-Law nr. 66/2018 (August 16) and the Ministerial Order nr. 33/2019 (January 25).
